About The Speaker

Javier Ramirez began his FMCS career as a Commissioner in 2005. Currently, Javier is a member of the U.S. Senior Executive Staff serving as the FMCS Deputy Director of Field Operations, responsible for leading all U.S. Federal Mediators. President Biden nominated Mr. Ramirez to be the 20th Director of FMCS in June 2021.

Javier mediated disputes in all sectors of the economy (except air and rail) in professions such as the performing arts, public safety, education, hospitality, healthcare, manufacturing, and packing houses, to name just a few. Javier facilitated and/ or mediated multi-party disputes in manufacturing, construction, and education. He was on the facilitation team for several regulatory negotiations, including the Department of Energy (DOE) negotiations that resulted in the largest energy-saving rule in DOE history.

Javier also trained and successfully facilitated parties in various collaborative bargaining models. Prior to FMCS, Javier spent over 14 years in labor relations.

UNION CONSTRUCTION From the Desk of the Executive Director



During our Annual Meeting last month, our Keynote Speaker, Attorney General Kwame Raoul and award winners DuPage County Chairman Dan Cronin and Comptroller Susana Mendoza spoke about voter protection, taxpayer protection and workers protection, respectively.

It was appropriate in a number

of ways, and I want to specifically focus on workers protection as it pertains to the pending Worker's Rights Amendment, which will be on the ballot as a Constitutional Amendment in November.

The Amendment reads in part "Employees shall have the fundamental right to organize and to bargain collectively through representatives of their own choosing for the purpose of negotiating wages, hours and working conditions, and to protect their economic welfare and safety at work."

Opposing groups are trying to muddy the facts with tawdry political bombast claiming that there are "connected" fingerprints on this legislation. In reality, the fingerprints on this amendment are those of the hard-working men and women who built this country and kept essential services in place for the past two years during a global pandemic, which tragically took thousands of their lives.

These essential workers – nurses, grocery store cashiers and stockers, bus drivers, firefighters, policemen and women, garbage collectors, truck drivers and more

- should have access to stable, family-sustaining jobs, as well as safe and secure workplaces. This Amendment will ensure that these workers will no longer have to fear for their livelihood with every election cycle.

As in the Wizard of Oz, the people behind the curtain are the multi-billion-dollar corporate donors. These corporations are pulling the levers that will impact working families' wages, benefits and time off, reduce safety regulations at worksites, and eliminate funding for training and workers' education.

The Workers' Rights Amendment is common sense. Countless studies have shown that workers living in free-bargaining states enjoy higher wages, better health care benefits, much safer work places and far fewer onthe-job deaths than their counterparts in right-to-work (for less) states.

Get ready for unhinged rhetoric to distract from the main focus of protecting the needs of Illinois workers. Remember the right-wing that opposes this amendment will tell you that the January 6th insurrection was "legitimate political discourse".

There is no hidden agenda in the Workers' Right Amendment. The playing field will be leveled for contractors who play by the rules and invest in worker safety. The Amendment is simply Illinois' way of protecting the working men and women in this state, and help them to come home safe to their loved ones at the end of the day.

Presidential Perspective



The partnership between Labor and Management continues to be a key element of success in the unionized construction industry. It is true that with any relationship, the partners do not always see eye to eye. It has been my experience as a Labor leader, working with our Management partners, that these nuances are based on perspective and goals of each of our organizations.

Organizations like CISCO, a labor-management institution, as well as Labor and Management affiliations most of us have in our individual crafts; creates an industryfocused conversation that makes both of us stronger. Discussions about technology impacts and trends, recruiting and retaining of a talented workforce representative of all the communities we serve, are important aspects for the continuing growth of our industry.

In addition, legislative actions that protect the area standards of our communities, as well as the health and safety standards protecting both the workforce and the citizens who enter buildings we erect, and drive on the roads and bridges we build and maintain; are critical components of a successful union labor-management model.

The more we understand each of our roles in this partnership, the smarter our decisions are going forward. Recently, the Sheet Metal Workers of SMART Local 265 (Labor) invited SMACNA Greater Chicago (Management) to participate in a program called "Apprentice for a Day". The employer sponsored representatives from SMACNA arrived at the training center in Carol Stream IL first thing in the morning. They were given an overview of what to expect, split into small groups and given their schedule for the day.

Each group moved through the day like an apprentice would. They spent an hour in each classroom or shop setting where they fabricated a sheet metal fitting in the shop, worked on an Autodesk REVIT project in the computer lab, performed some basic problem-solving exercises in the Commercial HVAC service lab and the Test Adjust and Balancing Lab, as well as an intro to Building Automation. SMACNA Greater Chicago's engagement in this and many other activities we do together helps align our perspectives, leverage each of our strengths and continues to enhance our industry.

The world we live in has many challenges and the complexity of construction projects continue to rise as we lean into Green Construction, technology enhancements that improve safety and efficiency, and the need to attract a talented workforce for labor and management in a diverse and inclusive way. Labor and Management, working together, in the way that CISCO does, will meet and exceed the demands of the construction industry.

Legislative Update - Spring Session Recap



The Illinois General Assembly has set a projected deadline of April 8th to wrap up its Spring Session of legislative action. CISCO has been monitoring activity and here

are three items of note: 1) A tax-reduction

proposal is being negotiated that will be in the area between \$1 billion - \$1.8 billion. Legislators on both sides of the aisle claim providing tax relief during this time of economic uncertainty is a top priority. Several tax-reduction options are on the table and the construction industry is continuing to monitor the plan to protect our interests.

2) **HB 5412** - This legislation amends the Wage Payment & Collection Act and seeks to hold general contractors and subcontractors liable for wage claims at any tier on a private construction project. Recent adoption of Amendment 3 which states: *"Primary contractors who are parties to a collective bargaining agreement on the project where the work is being performed shall be exempt."*

This broadened exemption will benefit more union contractors and add a layer of protection to signatories of collective bargaining agreements.

3) **SB 178** - This bill amends the Public Construction Bond Act and would reduce retainage on *public* construction projects. In response to discussion with stakeholders, plans are to amend SB 178 to provide for a 5% cap on retainage.

As contractors know, the combination of financing a surety bond and the inability to receive retainage payments in a timely manner for work completed, negatively impacts cash flow. A 5% retainage cap will ease contractors' cash flow burdens. This bill is likely to be moved to the Fall Veto Session.
