He completed the apprenticeship program and accepted a Teaching/ Painting Instructor position at Washburne Trade School in 1981. He continued as an instructor until 1990.

That year, John accepted a position as Business Representative.

In June of 2015, John was elected Business Manager/Secretary-Treasurer of District Council #14 and currently holds that position.

### CISCO BIDS FAREWELL TO LEGISLATIVE CO-CHAIR JEFF WEISS



Jeff Weiss, who served the past 5 years as CISCO's Legislative Committee Co-Chair - representing Management - is leaving the PCA of Greater Chicago, and

his final day will be Dec. 31, 2020.

Jeff helped the Legislative
Committee in numerous ways
with updates on a variety of bills most recently with SB 1636 which
became law in August, 2019. That
bill reduces the retainage under
private construction contracts from
10% to 5% once the contract is half
complete, and it remains at 5% for the
remainder of the contract.

PCA of Greater Chicago and IMSCA (Illinois Mechanical & Specialty Contractors Association) had both lobbied extensively for this change in the Prompt Payment Act.

Jeff, who was PCA's Public Affairs & Communications Director for the past 8 years, will be greatly missed.

#### THIS MONTH IN INDUSTRY HISTORY

On December 29, 1970, President Richard M. Nixon signed The Occupational Safety and Health Act, also known as the Williams-Steiger Act in honor of the two men who pressed so hard for its passage. The Act established three permanent agencies:

- The Occupational Safety and Health Administration (OSHA) within the Labor Department to set and enforce workplace safety and health standards;
- The National Institute for Occupational Safety and Health (NIOSH) in what was then the Department of Health, Education and Welfare to conduct research on occupational safety and health; and

- The Occupational Safety and Health Review Commission (OSHRC), an independent agency to adjudicate enforcement actions challenged by employers.

## ELECTORAL COLLEGE CERTIFIES BIDEN AS PRESIDENT-ELECT

On Monday, December 14, 2020, the Electoral College voted officially to affirm Joe Biden's victory.

Of equal importance is the fact that President-Elect Biden has added 27 union leaders to his transition team. With 15 agency review teams in place, each includes union officials.

The transition teams are being overseen by an advisory board, which Biden named earlier in the year.

This board includes two union Presidents, Teresa Romero of the United Farm Workers and Lonnie Stephenson of the International Brotherhood of Electrical Workers.
