APPRENTICESHIP OPPORTUNITY

The Iron Workers Local 63 Fence Erectors will be accepting applications for admission to the Fence Erectors Apprenticeship Program at 2523 W. Lexington in Broadview, IL 60155.

The applications will be accepted year-round on the following Wednesdays from 9:00 – 11:00 a.m. throughout 2020 on these dates: March 11, April 8, May 13, June 10, July 8, August 12, September 9, October 14, November 11 and December 9.

Interested individuals MUST obtain a letter of intent to hire from a signatory contractor. The letter must be signed by a principle or authorized person of the company. Signatory contractors along with additional apprenticeship program information can be found on the Local 63 website: www.iwlocal63.com/fenceapprentice.

Minimum Qualifications:

1) Must apply in person; 2) Be at least 18 years of age and provide a government issued picture ID showing date of birth; 3) Provide proof of two years completion of High School (transcripts, diploma, or GED certificate); 4) Applicants must be able to read, write and speak English; 5) Applicants must be able to physically perform the work of the trade; 6) You must pay a registration fee of \$25.00 – Money Order or a Cashier's Check ONLY. (Payable to: Local 63 Fence EAP)

AT TIME OF HIRE, applicants must: 1) Be able to pass a drug test; 2) Have a valid driver's license and reliable transportation; and 3) Furnish evidence of their physical fitness sufficient to perform the work of the trade – evidence shall be a statement from a certified physician.
