### ULLICO SIGNS ACQUISITION AGREEMENTS

Ullico Inc., a loyal supporter of CISCO, recently announced two acquisition agreements. The new investments will be for approximately \$200M each.

The first: Ullico Infrastructure Fund signed a definitive agreement to acquire GEP Bison Holdings, Inc., which owns 100% of the equity of Hearthstone Utilities, Inc. "Hearthstone"), a holding company that owns and operates six natural gas local distribution companies across five states in the United States. According to a Ullico press release, Hearthstone is a geographically diversified natural gas distribution platform. For the Ullico Infrastructure Fund, this platform represents a unique opportunity to wholly-own a regulated business.



Hearthstone's subsidiaries serve 5 states: Ohio (30 counties in northeast part of state near Cleveland and Columbus), Indiana (southeast corner of state: Dearborn, Franklin and Ohio counties), Maine, North Carolina and Montana.

The second announcement: Acquisition of Enwave Energy ("Enwave US"). Enwave Energy's market-leading US business currently operates and serves eight U.S. markets: Chicago, New Orleans, Houston, Los Angeles, Seattle, Portland, Denver, Syracuse.

The Chicago system has 5 production plants and 15 miles of distribution pipe serving the Loop, River North, West Loop, including the Mart, Old Post Office and 600 W. Chicago Ave.

### **IN OTHER NEWS**

Ullico also recently approved a J for Jobs investment and the project is under construction in Des Plaines. It's called the Ellinwood Apartments - a 7-story, Class A apartment development featuring 212 units (179,646 NRSF), 409 parking spots and 10,628 square feet of retail space.

It will include 12,000 sf of luxury interior amenities and 23,000 sf of exterior amenities, including a club lounge with kitchen, media room, co-working lounge, indoor/outdoor cabanas, outdoor pool, full size gym, covered bike racks, etc.
