IL AMERICAN WATER, IUOE LOCAL 150, LABORERS PARTNER ON PLA



Illinois American Water, the International Union of Operating Engineers Local 150 and Construction and General Laborers' District Council of Chicago and Vicinity (LDC) agreed on a 3-year Project Labor Agreement.

The scope of the PLA states that when Illinois American Water decides to use third-party contractors for project work, the work will be assigned to contractors that are signatories to a collective bargaining agreement with Local 150 and/or the LDC so that project work can be completed by the unions.

ILLINOIS CONSTITUTIONAL AMENDMENT BANNING RIGHT TO WORK (FOR LESS) LAWS TO BE ON 2022 BALLOT

Illinois residents will get the chance to vote next year on a constitutional amendment that would block the enactment of so-called "right-to-work" laws at the state or local level.

If adopted, the Workers Rights Amendment would prohibit these laws that try to gut union protection.

The proposed amendment won



legislative approval this week, and will be on the November 2022 ballot.

Supporters of the amendment say it will protect workers and their ability to organize and collectively bargain.

To be clear, "right-to-work" (for less) laws have nothing to do with anyone's right to secure employment. Instead, they have to do with whether union-represented workers can be asked to pay for the services they receive from labor organizations that negotiate on their behalf.



By denying unions of fees they would otherwise collect from workers, "right-to-work" (for less) laws weaken unions' ability to win wage increases, health and retirement benefits, and workplace safety standards.

Today, 27 states have RTW laws on the books, including Wisconsin, Michigan and Indiana. Illinois does not. And data shows that Illinois workers and our economy have fared better as a result.

A recent study by the Illinois Economic Policy Institute and Project for Middle Class Renewal at the University of Illinois at Urbana-Champaign states that wages and income growth are at least 6% higher in Illinois.

LEGISLATIVE UPDATE

With the Spring session concluding, here are a few items of interest:

1) HB 3437 (Illinois Hazardous Materials Workforce Training Act) - a law that would have called for the development of approved advanced safety training of workers at high hazard facilities to achieve a skilled/ trained workforce to perform this work, passed in the House, but stalled in the Senate as it was placed on Calendar Order of 3rd Reading May 31, 2021.

2) SB 2182 (Data Centers) passed the Senate unanimously earlier this month and provided some cleanup language to the tax credit act.

The House amendment that passed clarifies what is considered a data center, but another amendment sponsored by State Rep. Mark Walker, D-Arlington Heights, requires entities seeking a credit or seeking renewal of a credit to have a "labor peace agreement" he said would have the employer agreeing to not hinder any attempts for workers to unionize. The bill has been referred to Assignments.
