CISCO's Executive Director
Dan Allen was one of the featured
panelists for the May 28th session,
as the goal of the series is to deepen
understanding for the breadth of labor
and employment relations matters
during the COVID-19 pandemic.

"Now more than ever, the collaboration between union building trades workers and union contractors has been very important during the pandemic," Allen began.

"This cooperation had been in place for many years prior, but the undertaking was immense in order to make job sites safe and maintain social distancing on hi-rises was the toughest item to achieve. The amount of incidences were minimal, and the issues were addressed immediately."

Allen added that the pandemic will impact the construction industry. "Moving forward our job sites will be cleaner and safer than ever. New norms will include distancing, remote technology, 360 photos, virtual public meetings and safety talks; and unions will have a huge influence on these changes as we learn from what we are currently experiencing."

OSHA ISSUES COVID-19 GUIDANCE FOR THE CONSTRUCTION INDUSTRY



OSHA has just issued COVID-19 construction

industry. This closely mirrors the requirements in the NABTU/CPWR standards adopted by the Governing Board last month.

One aspect of the guidance that bears reading is OSHA's level of requirement for using respirators when workers are within six feet of other workers or civilians, but it very clearly infers that employers need to assess hazards and comply with 29 CFR 1910.134.

Recent protests throughout the City of Chicago and suburbs proved to be another challenge for the construction industry.

The pandemic, as we all know, has brought about a myriad of unprecedented changes involving social distancing, PPE necessities and many other safety initiatives. Union contractors and union building trades personnel have met these challenges with precision collaboration.

City of Chicago officials quickly recognized that the central business district would be one of the major hot spots for both peaceful and dangerous protesting.

The Mayor's Office and the **Building Commissioner notified** both the Chicago & Cook County **Building Trades and union contractors** associations about the parameters of closings and those in turn were quickly relayed to organizations throughout the industry.

HIRE360 ANNOUNCES COMMITTEE MEETINGS

HIRE360 announced its upcoming committee meeting schedule saying that supporting community business and connecting individuals to jobs is now more important than ever.

Since the stay at home order began, 300 people attended virtual orientations and 200 took the sample test online. The second cohort started virtual 12-hour test prep courses this week and with a few apprenticeships opening soon HIRE360 will be adding a third course shortly. The first interview training was conducted and another session will be added shortly.

LEGISLATIVE UPDATE



The Illinois General Assembly wrapped up a fourday special session in the early hours of Sunday, May 24th.

One of the bills of interest was the workers' compensation and unemployment insurance legislation that was negotiated through the "agreed bill process" - meaning that changes do not move forward unless all negotiators agree on language.

Those involved in the negotiations on this issue included the Illinois Manufacturers' Association, Illinois Retail Merchants Association, the Illinois AFL-CIO and the Illinois Trial Lawvers Association.

HB 2455 Senate Amendment #2 was the result of these negotiations and received bi-partisan support. The end result is that while this legislation allows essential employees to receive rebuttable presumption, the approved bill will allow for employers to rebut those claims using an ordinary level of rebuttal; meaning an employer simply has to show "some evidence" that the employer was engaged in best practices.

HB 2455 also includes changes to the unemployment insurance system. Due to a record number of layoffs as a result of the coronavirus outbreak, the fund has been drained.

In order to receive federal aid, Illinois had to make two important changes to the system: 1) Wave the one-week waiting period, and 2) making the layoffs a non-chargeable event for the employer.
