# **CISCO ON THE MOVE**



The Midwest Economic Policy Institute recently released a report on construction fatalities in the United States. Here are the key findings:

1) 4,339 construction workers lost their lives at work from 2011 through 2015. This means more than 16 construction workers die per week in the United States.

2) Construction worker fatalities cost the United States nearly \$5 billion in lost production, lost family income, pain and suffering costs, and reduced quality of life every year.

3) On-the-job fatalities are 13.8%-26.0% higher in states that do not have effective prevailing wage laws.

4) States prevent construction fatalities by implementing "high road" solutions: increasing resources to conduct OSHA inspections, maintaining prevailing wage laws, introducing local responsible bidder ordinances, and avoiding the attack on construction unions.

→ Video: <u>Indiana GOP Leader</u> <u>Admits Repealing Prevailing Wage</u> <u>"Hasn't Saved A Penny"</u>

A video has surfaced from a forum in Milwaukee where Republican Indiana House Assistant Majority Leader Ed Soliday angrily reveals that similar legislation passed in Indiana which went into effect in 2015 "hasn't saved a penny."

"We got rid of prevailing wage and so far it hasn't saved a penny," Soliday says during a question and answer session hosted by the Wisconsin Transportation Development Association in Milwaukee. In the video, Republican Soliday also mocks the outrageous claims about savings made by rightwing organizations like Americans for Prosperity. In Indiana, anti-worker groups claimed prevailing wage repeal would save taxpayers 22 percent on construction costs.

"The exaggerations in those hearings that we were going save 22 percent," Soliday says. "Well, total labor costs right now in road construction is about 22 percent, and I haven't noticed anyone who's going to work for free. [They claim] there's some magic state out there that's going to send all these workers into work for \$10 an hour and it's just not going to happen. Soliday adds, "So far, I haven't seen a dime of savings out of it."
