→ **May 21 - Working Safely Around Pipelines** - Special Guest Aaron Hoerchler, Operations Supervisor with Kinder Morgan. This session will focus on the importance of working together on a site that involves a pipeline. Aaron will emphasize the importance of communication and understanding the role the pipeline operator has while on your job site as required by federal statute.

→ **May 28 - Enforcement of the One-Call Law** - Special Guest from the Illinois Commerce Commission (ICC), One-Call Enforcement Division. This session will focus on the enforcement process and a review of historical trends in the enforcement division at the ICC. Tips and suggestions on how to maintain compliance with the law will be discussed.

LEGISLATIVE UPDATE



The Illinois General Assembly will return to Springfield to hold a three-day session (May 20-22). The agenda will include among others: COVID-19 pandemic issues, state budget, economic recovery, infrastructure projects/funding, and the 2020 General Election. Some construction-related bills that are being monitored include:

1) Workers Compensation - Consideration of a rule regarding essential workers who contract COVID-19.

2) Prompt Payment Act - A new proposal to change the interest percentage for state vendors and providers after six months of non-payment.

3) HB 5769 - New legislation requiring essential employers to provide protective equipment to employees/independent contractors.

Filing begins on June 1, 2020. The information (collectively bargained wage and fringe benefit rates paid to your members for work they perform on public works projects) you submit to the portal during the month of June will assist IDOL in preparing its annual prevailing rate publication on July 15.
