CHICAGO REGIONAL COUNCIL OF CARPENTERS EXPANDS NATIONWIDE



The Chicago Regional Council of Carpenters (CRCC) will become one of the largest regional labor unions in the country under a

restructuring arrangement that will add 20,000 members, boosting the Chicago Carpenters Union's total membership to 50,000 - plus men and women.

According to a CRCC press release issued last week, the announcement that geographical and trade jurisdiction of the former St. Louis-Kansas City Carpenters Regional Council has been assigned to the Chicago Regional Council. The decision, the release stated, was made as a means to increase oversight of operations, reduce costs, maximize available resources, and increase market competitiveness.

Gary Perinar, Executive Secretary-Treasurer of the Chicago Regional Council, said he welcomed the new reorganization, which will make the already formidable union even stronger.

"I look forward to building a long and productive working relationship with the representatives, staff, instructors, contractors and members of the former St. Louis-Kansas City Carpenters Regional Council," said Perinar.

"This reorganization presents real opportunities to increase our market share above and beyond our 70 percent target goal. It's a win for our signatory contractors, it's a win for the communities in which we live and work, and most importantly, it's a win for our hardworking members."

Tom McTavish began serving on the CISCO Board in 2007, and CISCO wishes to thank him for his leadership and 14 years of service!


30TH ANNUAL RERUM NOVARUM AWARD - OCTOBER 19TH

FCAI PRESENTS "PROTECTING WORKERS' RIGHTS IN ILLINOIS"

Last week, the Finishing
Contractors Association of Illinois
hosted a webinar on the topic of
Protecting Workers' Rights in Illinois
that featured Frank Manzo IV, Policy
Director for the Illinois Economic
Policy Institute (ILEPI).



Manzo's presentation focused on the main point that "Illinois fares better than 'Right-to-Work' (for less) states

on 10 important economic outcomes."

Manzo stated up front that "the economies of states with unencumbered collective bargaining, are better off than "Right-to-Work" (for less) states.

Manzo offered 5 key takeaways from his presentation based on extensive ILEPI research:

- Illinois workers earn higher wages and better benefits,
- Illinois workers are better educated and more productive,
- 3) Illinois workers have fewer onthe-job fatalities,
- 4) Voters support unions and reject right-to-work laws, and
- 5) Right-to-work states have slower economic growth.

RCEC VIRTUAL ECONOMIC CONFERENCE - SEPT. 30, 2021

The Residential Construction Employers Council held its Annual Economic Conference from 8:00 -10:00 a.m. on Thursday, September 30th. The Conference was held virtually.

Leslie McGranahan, VP and Director of Regional Research, Federal Reserve Bank of Chicago, Economic Research Dept. was the speaker.

McGranahan's primary research related to the effects of federal, state and local government policy on individuals and households.

Her presentation focused mainly on the recovery from the global pandemic. She touched on the impact that the delta variant has had on countries where key supply chains are manufactured, such as computer chips, as one factor that is slowing economic growth and decreasing purchases due to long wait times for goods in specific industries.

The event was co-sponsored by the Residential Home Builders Alliance.
