CISCO Annual Meeting Set For February 11, 2022

CISCO's Annual Meeting will return to its regular annual time-frame and be held on Friday, February 11, 2022. Two New Board Appointees Replace Outgoing Members

Mike joined Local 150 as

In December 2018, Michael was appointed as Vice President, and in 2021, Michael was appointed Recording-Corresponding Secretary after the retirement of Steven Cisco.

Steve Cisco began serving on the CISCO Board in 1990 (two years after CISCO was created), and he was the longest tenured Board member (31 years) upon his retirement. Thank you Steve for your service!

From the Desk of the Executive Director



As you probably read on the first page of this newsletter, CISCO's Board named two new board members to replace two long-term board members who announced their retirement.

One board member, Steve Cisco, had served on the board for 31 years, while the other, Tom McTavish, had served for 14 years.

No words can describe the gratitude that the other members of the Board and myself have for the dedication and commitment that these two gentlemen provided to our organization.

As a non-profit, CISCO relies on this kind of volunteerism and their service can be described as almost heroic. Servant leadership, as detailed in Robert Greenleaf's book of the same name, has experienced a rapid shift in recent decades in many businesses and non-profit organizations.

Servant leadership seeks to involve others in decision making, is strongly based in ethical and caring behavior, and enhances the growth of workers while improving the caring and quality of organizational life.

Union groups praised the bill's language requiring that all major renewable construction projects must have project labor agreements in place to hire union labor, while non-residential projects, with few exceptions, would be required to pay a prevailing wage.

Strong leadership is essential in other sectors of society as well - including government.

This summer, the Illinois General Assembly passed and Governor Pritzker signed into law the Climate and Equitable Jobs Act.

The bill's clean energy and efficiency highlights are:

- Invests \$580 million/year to increase the state's clean energy from 9% to 50% by 2040 and creates thousands of new jobs.
- Community solar programs increase from \$10 million to \$50 per year.
- Expands labor standards in clean energy projects throughout the state.

On the transportation front, the bill also provides \$78 million a year to electric transportation, with 45% of benefits going to low-income communities.

Union groups praised the bill's language requiring that all major renewable construction projects must have project labor agreements in place to hire union labor, while non-residential projects, with few exceptions, would be required to pay a prevailing wage.

The entire energy package with labor standards was made possible as entities such as environmental groups, the Illinois AFL-CIO, and other labor leaders spent countless hours negotiating a model for the country.

So as you can see, leadership in government can usher in dramatic change, while leaders such as Steve and Tom had a profound impact on their former respective organizations, as well as CISCO's.

CISCO Announces Scholarship Program Underway for 2022 Awards

CISCO has begun to accept applications for its long-standing Annual Scholarship Awards Program.

Presidential Perspective



Thanksgiving is right around the corner, and the union construction industry has many reasons to be thankful.

Even though some projects were put on hold during the pandemic, many projects continued on their way to completion, while more are breaking ground. Optimism remains high and recent groundbreakings and contractor updates sent a strong signal to the industry. These projects will provide thousands of construction jobs and hundreds of permanent jobs according to projections.

Some of the projects I am speaking of all got significant press coverage - the **Obama Presidential Center**, Sterling Bay's first **Lincoln Yards** building, and the third tower (Wolf Point South) of the **Wolf Point** project being financed by the AFL-CIO Building Investment Trust ("BIT") and the AFL-CIO Investment Trust Corporation ("ITC").

The BIT is the equity investor for all three phases of the Wolf Point development, investing union pension capital to generate over \$1.5 billion in total development in downtown Chicago. In addition, the BIT's comprehensive labor policies will generate over 6 million hours of work for union construction trades on the site.

I have mentioned Sterling Bay as one of our newer Associate Members in this column before. They are the developer of the dynamic Lincoln Yards project, a vibrant new multi-billion dollar, multi-phased development that will connect Lincoln Park and Bucktown on 50 acres of riverfront property. Just as significant, CISCO and Sterling Bay have partnered to recruit a diverse new generation of young adults and present them with the opportunity to apply to a building trades apprenticeship program.

The same approach is being conducted for the Obama Presidential Center as the project encouraged a diverse construction pipeline prior to the Center's construction, and continues to push that effort during and after.

Other projects are moving forward such as **The 78**, a project set on 62 acres with 13 million square feet of office, residential and retail space, and the \$8.5 billion **O'Hare 21** modernization project.

As CISCO receives submittals for its annual Project of the Year awards, we will continue to be reminded of how our union contractors and building trades members collaborate on constructing some of the top projects in the country, which further demonstrates the success of CISCO's labor-management model.

Legislative Update - End of Veto Session Roundup



The Illinois General
Assembly convened in
Springfield during the last
week of October to wrap up
the final week of the 2021
fall veto session. While the
first week of veto session was
relatively quiet with a light
workload – the second week

of veto session was the complete opposite.

Lawmakers worked long hours and approved many of their top legislative priorities, including approval of the new congressional map (HB 1291) and legislation clarifying the intent of the Health Care Right of Conscience Act (SB 1169).

CONSTRUCTION-RELATED BILLS

Legislators also debated bills of particular interest to the construction industry including approval of the Reimagining Electric Vehicles in Illinois Act (HB 1769). However, the issue that received the most discussion was legislation seeking to amend the Wage Payment and Collection Act (HB 3293).

An amendment was filed to HB 3293 (Sen. Castro/Rep. Gong-Gershowitz); seeking to hold general contractors and subcontractors liable for wage claims at any tier on a private construction project.

The amendment is an initiative of the Mid-America Carpenters Regional Council and is supported by the Illinois AFL-CIO. Proponents of the amendment argue the bill:

- Is aimed at protecting workers from wage theft by bad-actors/subcontractors.
- Levels the playing field as documented cases of wage theft have occurred when a subcontractor misclassifies a worker in order to dodge proper wage payment and benefits. This puts union signatory contractors at a disadvantage for competitively bid projects.

Those opposed to the legislation identified potential unintended consequences of the legislation:

- In an effort to limit their liability, general contractors may be incentivized to self-perform more work and not hire subcontractors – resulting in diminished project and employment opportunities for subcontractors.
- Creates a barrier of entry for small businesses by encouraging general contractors to work with more financially established companies.

HB 3293 as amended was approved by the Senate the same day it was introduced, and arrived in the House the following day. The amended bill was approved by the House Executive Committee and sent to the House floor for consideration in the evening.

However, the Illinois General Assembly adjourned without passing the bill. HB 3293 awaits a concurrence vote in the House, and it will likely be addressed when lawmakers return in January.

"Construction Talks" Features Painters District Council #14

"Construction Talks" most recent visit was to the Training Center of the Painters District Council #14 in Berkley. This was the 9th episode in the series which began in 2020.

The webinar featured Dan Penski, Jr., Director of Training (pictured above), Instructor Veronica Leal, and second year apprentice Rahm Jointer. Also involved in the panel discussion were CISCO's Education-to-Careers Director Jamillah Muhammad, and Brandy Phillips and Sam Hunt from the CTA.

The 50-minute webinar featured Dan Penski explaining the requirements needed to apply to the program, as well as a description of the trades' duties.

In addition, Ms. Leal and Mr. Jointer explained how they got interested in the trade and their experiences during training and how it changed their lives.
